5. Carry out any other accessory or complementary actions necessary for the proper management of the Holder's aliases before the Alias Registry.

I likewise **expressly assume** liability that may arise in cases where the data provided and/or the statements contained in this document are false or inaccurate, as well as in cases where the representation and/or powers claimed are false or insufficient to grant this authorization, in accordance with applicable legislation.

- The Authorized Representative holds a valid digital certificate enabled to act in Spain.
